1. Fill in the form on the back of this page.

3. Check the day of the month for your deduction to be made.
4. Read the agreement on the back and then sign and date the form.
5. Return the form with a voided blank check or a photocopy of the check from your personal checking account or a deposit slip from your savings account.

The Automatic Electronic Giving Plan

Creation Moments will inform you by letter that you have been enrolled in this plan and the date of the first deduction.

The first automatic deduction will occur in about six weeks. **And remember – you can increase, alter or end your pledge at any time by simply notifying us.** Your monthly amount will be paid automatically until you let us know in writing you wish to stop.

A record of each deduction will show on your monthly bank statement. You will receive a tax receipt from Creation Moments monthly.
